There occurred no changes after the communication of the rating to the rating object.

**Rating summary:**

Due to regulatory requirements, Creditreform Rating has withdrawn the outlook stable of the unsolicited ratings of the above-mentioned rating objects and replaced it with "Watch UNW" (Watch uncertain). The reason is an adjustment made by Creditreform Rating to the methodology for corporate ratings Version 2.4 as of July 1, 2022. In addition to editorial changes, clarifications were made with regard to the industry analysis. Further details can be found in the press release (news) published on our website on May 25, 2022. The affected rating objects will be subject to a review within a period of up to six months.

**Primary key rating drivers:**

- Introduction of the methodology for Corporate Ratings 2.4 on July 1, 2022

**ESG-criteria:**

There are no other attributes and limitations of the credit rating or rating outlook other than those displayed on the Creditreform Rating AG website. With respect to the rated entity, Creditreform Rating AG regarded available historical data as sufficient.

Between the time of disclosure of the credit rating to the rated entity and the public disclosure, no amendments were made to the credit rating.

In the case of a rating outlook, the time horizon is provided during which a change in the credit rating is expected. This information is available within the Basic Data Information Card.
